## Micro- credentials

The Centre for Adult Learning & Professional Development offers Micro-credentials (short accredited courses) for the Academic Year 2023/24. These Micro-credentials are delivered in a flexible way, some are delivered on campus but the majority are online. The subject areas are drawn from consultation with enterprise and industry partners' skills needs, identified through future skills reports published over the last 3 years. The courses are intended to upskill and reskill the workforce, and to future-proof Irish businesses and society during challenging and changing times.

These courses are particularly suitable for work-based learners who want to **upskill** on one or more topics of interest to add to their professional skills profile.

# Environmental Management for Organisations

Drawing on contemporary examples, Environmental Planning and Management for Organisations will explore the roots and principles of environmental planning and management in practice, introducing students to a range of conceptual and practical approaches. This is a core module focusing on processes, scale and case studies in environmental planning in industrial and commercial organisations and laying the foundation for the other modules.

## Green Lab Principles and Practice

This Micro-credential aims to provide a general overview of key environmental concepts such as climate change, plastic pollution, sustainability, and biodiversity. It will briefly explore how perspectives from psychology, sociology, communication, economics, and the study of ethics and governance provide us with insights into how perception and behaviour influence responses to environmental issues. In addition, the lifecycle of materials, and the environmental impact of the resources and equipment typically used in scientific laboratories will be examined in some detail.

# Honey Bee Health (Apiculture)

In this Micro-credential, we aim to provide beekeepers with the necessary skills and knowledge to be able to identify the criteria needed to raise healthy honeybees. Key to this is good animal husbandry and knowledge of pests and diseases of the honeybee. Being able to assess the risks associated with poor apiary hygiene, disease hot spots, overstocking and habitat loss, puts the beekeeper in control. A clear benefit of the Micro-credential is increased productivity (under the right weather conditions) which is reflected in the amount of surplus honey available to the beekeeper should they choose to harvest it.



## Future of Artificial Intelligence

This module aims to give learners an understanding of current trends in Artificial Intelligence (AI) and the future development of the field, covering both academic research and industrial deployments. The focus of the module will be on the challenges and opportunities that developments in AI present to individuals, organisations, and society. Learners will gain experience of critiquing literature on AI and evaluating the technological readiness of various AI approaches to solve specific real-world problems.

## Data Analysis and Visualisation

This module will cover analysis and visualisation to transform data into usable insight. It will use graphical data visualisation tools for fast insight without using software coding. It is a mix of theoretical and practical aspects of Data Analysis and Visualisation. The module will teach both principles and practice in order to avoid common visualisation errors which lead to inaccessible or misleading results. A programming-free module will be taught using different data analysis and visualisation tools. Tools will be taught from scratch, therefore, no prior knowledge of computer science or programming is required. Learners will require access to a computer where they can install the required tools. The module is taught using software and resources that are free and open source.

The development of AI and its application in business contexts raises ethical and legal questions which require serious consideration. This module will provide complementary discussions of legal and ethical perspectives on pertinent AI-related issues for managers. The most prominent ethical issue is privacy, automated inferences about persons (e.g. employees or customers), and the framework of contextual integrity. This leads to the law of data protection, which creates a regulatory framework for the processing of information on individuals and is therefore relevant to business analytics, online marketing, and content regulation.

Agus obair an tseimeastair seo á cur i gcrích, beifear ag cur leis an gcúlra stairiúil agus teoirice a pléadh sa chéad seimeastar. Is iomaí cáipéis taighde agus beartais a foilsíodh le fiche bliain anuas: Tuarascáil Choimisiún na Gaeltachta (2002): Staidéar Cuimsitheach Teangeolaíoch ar úsáid na Gaeilge sa Ghaeltacht (2007). Sa mhodúl seo, breathnófar ar na tátail a baineadh as na cáipéisí taighde sin chomh maith leis an bhfreagra a thug an stát orthu sa Straitéis 20 Bliain don Ghaeilge 2010-2030 agus in Acht na Gaeltachta 2012 go háirithe. Is in Acht na Gaeltachta 2012 a leagtar amach próiseas na pleanála teanga in Éirinn, bíodh sin sna Limistéir Pleanála Teanga Ghaeltachta, sna Bailte Seirbhíse Gaeltachta nó sna Líonraí Gaeilge. Caithfear solas ar bhuanna agus ar laincisí an chórais sin agus déanfar measúnú ar dhornán pleananna teanga a d'eascair as.

## An Anailís Sochtheangeolaíochta II

Sa mhodúl seo, déanfar plé agus anailís ar phróiseas an aistrithe teanga agus ar na comharthaí sóirt a bhaineann leis. Pléifear an tionchar a bhíonn ag an aistriú teanga ní hamháin ar an bpobal urlabhra, ach ar an gcineál teanga a labhraítear chomh maith céanna. Músclaíonn sé seo ceisteanna idé-eolaíochta a bhaineann le dlisteanas agus barántúlacht teanga (Woolard, 2016). Déanfar plé, mar sin, ar an measúnú a dhéanann an pobal urlabhra ar leaganacha nua cainte a thagann chun cinn ina measc mar thoradh ar phróiseas an aistrithe teanga (Ó Murchadha, 2019). Cuirfear oiliúint ar an mac léinn cén chaoi le hanailís dioscúrsa a dhéanamh, ar thras-scríbhinní agallaimh, mar shampla, chun go bhféadfaí léargas a fháil ar an idé-eolaíocht atá ag cainteoir i leith na héagsúlachta teanga. Ina theannta sin, déanfar plé ar phróiseas an chothaithe teanga trí bhéim a leagan ar nuachainteoirí na Gaeilge (Walsh agus O'Rourke, 2015).



The context and content for the application of the law, and particularly for legal practice, are continually changing. Rapid developments in machine learning and artificial intelligence are significant elements in this process. The aim of this module is provide students with the ability to understand the relationship between law and technology from both a theoretical and practical perspective. It will explore how technology and law are inter-related, with legal automation transforming the nature of legal practice, while law regulates the development of technology. The module seeks to provide students with hand-ons experience in developing useful tools for those working with the law, while also giving a grounding in critical perspectives on law and technology and enabling them to make informed decisions about when particular technologies are appropriate.

Lawyers and technologists are now using software tools as a means of analysing legal information, including case law, legislation, and practice data. This module explores the use of analytics for and by lawyers. Incorporating insights from the use of analytics in other disciplines, and decades of experience in the development of business information systems, it provides learners with an opportunity to develop critical perspectives on the appropriateness of legal analytics in different contexts while also building their practical data management and analysis skills through hands-on projects.



This Micro-credential will help you to become proficient in founder selling: communicating your vision for your product/service and understanding how others may value your new offering.

- Are you a new business founder with a great product or service idea, but you don't know who to sell to or how to sell it?
- Are you an established business owner and working on a new product or service to bring to market and need to revisit your customer pipeline and sales strategy?
- Are you a creative professional Solopreneur with a passion for creativity but no sales experience or not enough customers?

Research shows that founder selling is critical to new venture development. Yet, entrepreneurs are often unprepared for this challenge. By the end of this course students will have a sales strategy for their business to elevate their sales journey.

## Digital Literacy and Young People

While young people are considered 'digital natives' there are still gaps in knowledge on how to assess the quality and reliability of information and on how to decide which sources are trustworthy. This microcredential will also introduces the concept of artificial intelligence (AI), and discuss the challenges and opportunities it brings. Lastly, the module will address e-health literacy in young people.

Many of the strategies and skills called for by policies such as the Consent Framework are innovative, bringing an associated need for support for professional development. We are therefore learning together, and working in the area will be well served by developing a learning community that can mutually support a best practice model.




